1 Introduction

This report presents a detailed overview of all activities during the year 2013 that were carried out at EUROLAB, department DAS, GESIS – Leibniz Institute for the Social Sciences. The EUROLAB was established in 1996 as an access facility to the resources available at the GESIS data archive (formerly ZA). It was supported by the European Commission within the 4th, 5th and 6th Framework Programs. The EUROLAB is recognized as an important international research infrastructure to support high level comparative research in the social sciences. Since 1996 about 350 researchers from over thirty countries all over the world have worked at the EUROLAB for more than 5500 days altogether. Around 100 books, articles and conference papers have been published on the basis of research at the EUROLAB so far.

The EUROLAB offers visiting researchers on-site access to comparative social research data (including data with restricted access), access to scientific literature via the special GESIS library on empirical social research and through online access to academic journals. The EUROLAB provides access to a personal working place, to standard and highly advanced statistical analysis software and methodological and theoretical advice from internal and external experts. Furthermore, practical and logistic support as well as partly financial support is provided to EUROLAB visiting researchers. The EUROLAB announces two calls a year for about ten financially supported visits. Applications for visits without financial support, i.e. self-funded visits, are accepted anytime and the share of researchers coming on their own means has been growing in the last years. In addition, EUROLAB organizes international symposia and conferences in cooperation with GESIS colleagues in order to encourage academic debate on major societal issues.

The following sections inform about projects of visiting researchers, present statistical background information about visiting researchers and also report on the scientific activities of EUROLAB team members: Section 2 provides a summary overview of the visiting researchers, their home country, position etc. This is followed by an overview of the projects carried out by visiting researchers, the related scientific publications and the presentations EUROLAB researchers held during their visit at GESIS. Section 4 contains the results of the user evaluation of services offered by the EUROLAB. In the following, information is given about the EUROLAB User Meeting 2013 in section 5. The authors' conference "Values, Crisis and Democracy" which took place in September 2013 and was organized by the EUROLAB in co-operation with the director of the Data Archive for the Social Sciences, PD Dr. Hermann

Dülmer, is presented in section 6. Section 7 introduces the Leibniz – DAAD research fellow hosted by the EUROLAB in 2013. Finally, a last section contains information about the activities of the EUROLAB staff and lists publications, presentations, functions, memberships and other achievements as well as academic teaching and personnel changes in 2013.

2 Overview of visiting researchers at EUROLAB




Figure 2.1: Duration of stay in days by country of home institution and type of funding of visiting researchers in 2013¹




Figure 2.2: Funding of visiting researchers in 2013 (n=24)

Overall, in 2013 the EUROLAB hosted 24 visiting researchers who worked altogether at 656 days on their individual projects (cf. Figure 2.1). Out of these 24 researchers 10 were funded fully by EUROLAB (cf. Figure 2.2) after positively being evaluated by the International Selection Panel. In 2013 the Selection Panel has evaluated 113 applications out of which 11 for self-funded research visits. This shows the high demand among researchers in Europe and worldwide for accessing social sciences research infrastructures as the EUROLAB. 6 research visits were fully self-funded, 1 research visit was partly funded by EUROLAB. 1 long-term visit was a Leibniz-DAAD fellowship and 6 research visits were scientists invited by DAS, GESIS, and who were hosted by the EUROLAB.

EUROLAB grants are a great possibility to enhance international visibility of GESIS and to attract researchers from all over the world to make use of various GESIS services. Following each call we also receive an increasing number of researchers applying for a research visit with own funding which indicates that there is a need for on-site access to social sciences data and support within an adequate research environment. Figure 2.1 shows where the researchers came from and the distributions of self-funded vs. granted research visits in 2013.

Looking at the country of the home institutions, the visiting researchers came from 11 different countries in Europe, and the USA. In each case, two visitors came from institutions in Romania, Italy, Spain, Russia and Portugal. One researcher came from Estonia, Finland, Germany, Poland, Switzerland, the Ukraine and the USA, respectively. As can be seen Romanian researchers spent 90 access days at the EUROLAB in 2013, all of these were self-funded. Thereafter, Switzerland follows with 65 self-funded access days and Russia with 42 access days granted by EUROLAB. More than half of all the access days provided by EUROLAB were on own funding (201) and 168 access days were support by EUROLAB grants. The 7 researchers who worked at the EUROLAB on their own costs came from different countries: One researcher respectively came from Italy, Switzerland, Portugal, Finland and Spain. Two came from institutions in Romania.

Without the Leibniz-DAAD fellowship scholar, whose long visit (1 year = 230 days) would strongly bias the distribution and without visiting researchers from DAS.




Figure 2.3: Research status of visiting researchers in 2013 (n=24)

Figure 2.3 shows the research status of all 24 researchers who worked at the EUROLAB in 2013 and shows the high level of academic positions held by the visitors: while 3 were PhD Students, EUROLAB hosted 11 Postdocs and 10 experienced Professors.




Figure 2.4: Age of visiting researchers in 2013 (n=24)

The gender distribution of EUROLAB visiting researchers in 2013 show a bias towards men who were with 15 persons overrepresented as compared to the 9 women that were hosted . The age distribution in Figure 2.4 indicates that most visitors were between 35 and

44 years. This coincides with research status (Figure 2.3) as most visitors were postdoctoral and professorial researchers.

Two of the most important reasons for researchers to apply for a stay at EUROLAB are the possibilities to analyse most recent data sets with state of the art statistical software. What are the data sets researchers demanded the most and which programs did they use to analyse them? Similar to the previous year, the most frequently used data sets are the European Values Study 2008, the European Social Survey, and various waves of the International Social Survey Program and of the Eurobarometer. Other data sets that were used are the Comparative Study of Electoral Systems (CSES) and various Elections studies for the field of political science. One researcher also gained access to the restricted data of the pairfam panel (panel of intimate relationships and family dynamics). Despite the growing data resources available in the web and the possibilities to analyse them online, researchers profit from conducting their empirical projects in a research environment which includes expert advice, colleagues, technical equipment and the right statistical software: The most popular programs (i.e. nearly all researchers used them) are SPSS and STATA. HLM, special software designed for multi-level regression analyses, is also used by many of the visiting researchers. Some researcher requested AMOS, MPlus and Lisrel. However, given the temporary nature of versions of software programs it is not possible to calculate preferences for the next years: The release of a new version of some programs not used in 2013 may attract researchers to apply their statistical methods with the new software.

This book is the result of a longer and fruitful cooperation between Max Koch from Lund University, Sweden and the EUROLAB. It started in May 2011 with an authors' workshop on the "Destandardisation of employment in the EU" and is continued with different topics and projects until today.



About this book: 'Non-standard' employment is becoming more common. Fewer people are working full-time and/or have permanent employment contracts; more are working part-time, have fixed-term contracts or are self-employed. Many scholars have pointed to the negative consequences of this development, including 'precarious' forms of employment and in-work poverty. This volume provides a thorough theoretical and empirical analysis these processes understanding by 'Destandardisation' of employment in Europe and the associated modifications in socio-economic regulation both at national and EU level. The book provides country studies of the UK, Spain, Germany, Poland, Croatia, and the Nordic countries and offers comparative European analyses of part-time and fixed-term employment in relation to in-work poverty, exclusion and

anomie. Emphasis is on 'best practice' in the governance of non-standard employment. Is there evidence for a new and socially inclusive European employment standard?

4 Evaluation of the EUROLAB by visiting researchers 2011–2013

The following graphs and numbers come from an online questionnaire which visiting researchers are asked to fill in shortly after their stay in Cologne. It covers, among others, the satisfaction with different services of the EUROLAB, what services researchers used during their visit, and how they got to know about the EUROLAB. So far, 32 researchers have completed the questionnaire.




Figure 5.1: Kind of Support used, multiple answers possible (n=32)

As Figure 5.1 demonstrates the main reason for coming to the EUROLAB still is the access to social science data sets. Also very important for researchers are meetings with GESIS staff to get expert advice on their topics as well as the access to latest and specialized statistical software. 21 researchers made use of the GESIS library and 6 took the opportunity of working at the EUROLAB to conduct a joint research project, either together with other visiting researchers or with EUROLAB and GESIS staff. One researcher used the opportunity to also attend a GESIS training seminar during the visit.




Figure 5.2: Satisfaction with the EUROLAB (Mean values from scales with 1=very poor to 5=very good, n=32)

Figure 5.2 shows the satisfaction of visiting researchers with different aspects of their stay at the EUROLAB. In general, all aspects were evaluated as very good which is reflected by the high overall appreciation of the research visit (4,84). Regarding single aspects, satisfaction with logistic and administrative support score the highest (4,78). This is followed by the satisfaction for scientific support and the intellectual environment as well as technical support. Overall, the satisfaction of the EUROLAB visiting researchers remains at a very high level during the whole period.




Figure 5.3: How did you hear about EUROLAB? (Multiple answers possible, n=32)

There are different sources from which visitors hear about the services of EUROLAB. The most frequently occurring sources are, as Figure 5.3 demonstrates, previous visitors who spread the knowledge and their experiences at EUROLAB in their home institutions and among their academic networks. Contact between EUROLAB staff and researchers – usually in the context of conferences and workshops – also plays an important role. This is followed by more formal dissemination activities like periodically e-mails from EUROLAB and the information on the EUROLAB websites. Few researchers learnt about EUROLAB and its offers from newsletters of professional organizations or from other mailing lists.

5 EUROLAB User Meeting 2013

On October 11th, 2013, former and current visiting researchers of the EUROLAB as well as EUROLAB staff met in Cologne to present and discuss their research among each other and with GESIS staff. 6 Authors' Conference: Values, Crisis and Democracy

On September the 26th and 27th, 2013, international experts met at GESIS in Cologne to discuss interrelations between economic crises, political attitudes and value change. Moreover, one of the central questions in the focus of the conference was how crises affect trust in political institutions and political participation.

The conference was organized by Malina Voicu and Ingvill C. Mochmann (EUROLAB) and Hermann Dülmer (Director of the department 'Data Archive for the Social Sciences'). Eldad Davidov, University of Zurich, opened the conference with a keynote speech in which he addressed the role of basic human values for the formation of attitudes using the examples of immigration and homosexuality.

In the course of the two days eleven more presentations were given which had been peer-reviewed prior to the conference by the organisers and a high-level international review panel including in alphabetic order: Amy Alexander, Jaak Billiet, Eldad Davidov, Dominique Joye, Oddbjørn Knutsen and Jacques Hagenaars. The outcome will be published in 2014/15 in a volume edited by Malina Voicu, Ingvill C. Mochmann and Hermann Dülmer.

The call for papers

The crisis that has affected the global economy during the last years is experienced in diverse ways in different countries. The economic decline has affected people's involvement in political and social life, the relationships between citizens and public institution and the general public attitudes towards states and their role in redistributing resources within society. The effects are moderated by macro level frameworks like public and social policies, but patterns of social values play a role as well. Generally speaking, social values shape and are shaped by historical, political, cultural and socio-economic features of each society. Different scholars studying social values have drawn maps to delineate geographical regions with particular value patterns, depending on the main values orientation shared by the population (like Schwartz, Inglehart, Welzel or Hofstede). Is there any connection between the map of social values and the effects of economic crisis? Contributors are encouraged to use comparative data bases like European Value Study, World Values Survey, European Social Survey, International Social Survey Project, or EuroBarometer that allow wider cross-sectional and longitudinal comparisons.

Please send us an extended outline of 800 words to eurolab@gesis.org, which should include information about theoretical framework, data, methods and expected results. The deadline for abstract submission is 30th of January 2013. An international panel of experts will evaluate the proposals by 15th of March 2013 and will invite the selected authors to submit a full paper by July 15th 2013. The full papers will be presented and discussed at the Authors' Conference, held in Cologne between September 26th and 27th 2013. The selected papers will be published. You may also consider using EUROLAB facilities for preparing your contribution.

7 Leibniz-DAAD fellowship scholar at GESIS hosted by EUROLAB

From April 1st 2013 until March 31st post-doctoral researcher Francesco Sarracino from the Laboratory for Comparative Social Research in Luxembourg, worked at the EUROLAB in the context of a Leibniz-DAAD fellowship. The title of his project was "Social capital and subjective well-being: an assessment of the causal nexus". The goal of this joint study was to analyse the connection between social capital and well-being from a cross-cultural comparative perspective as well as from longitudinal perspective, using survey data.



Francesco Sarracino presented different parts of his research to interested colleagues at GESIS in Cologne at three presentations: The first was on 27.6.2013 and entitled "Happy for How Long? How Social Capital and GDP relate to Happiness over Time". The second took place in the course of the authors' conference "Values, Crisis and Democracy" and was a joint project together with Malgorzata Mikucka, University of Louvain-la-Neuve, and concerned with "The relational component of people's well-being at the roots of the 2008 economic crises". He held his

third presentation on occasion of the EUROLAB user meeting in October. This time he spoke about "The dark side of Chinese growth: Explaining Chinese decreasing well-being in times of economic growth".
