1. Introduction¹

During the AGIPEB-Project several event history analyses were implemented to find answers to the question to what extent fixed-term employment as well as other sociostructural or labour market variables influence transition-rates into partnership-stabilizing events (Baron 2015, Baron, Rapp 2017b, Baron et al. 2015). These events under consideration were: cohabitation, marriage, parenthood and homeownership. While we relied on cox regressions and exponential models in earlier studies, we went on to use piecewise-constant models in later phases of the project.

Other than cox regression models or exponential models, piecewise-constant models allow for calculating flexible transition rates for each time-span under consideration (Blossfeld et al. 2007: 116-127). In our models, process-time and, thus, all the event history episodes were modeled using each participant's reported occupational and partnership biography.

Furthermore, piecewise-constant models give the opportunity to implement time-invariant as well time-dependent covariates. Examples for the former variable-type would be gender or levels of education, examples for the latter would be age or type of employment spell, such as fixed-term employment, permanent employment or being in education.

Event history analysis, especially piecewise-constant models, often require detailed data transformation and sophisticated data management techniques. First, each interviewee's sub-dataset has to be reshaped from wide- into long-format. This means that there is not only one row per interview in the dataset containing each participant's cross sectional data, but each participant is recorded with each of his reported event history episode. If there are, for example, five employment spells – one educational spell, two spells of fixed-term and two of permanent employment – then this particular participant's sub-dataset will contain five rows of reported covariates.

Second, to allow for calculating – flexible as well as constant – transition-rates the change of every time-dependent covariate has to be taken into consideration for each participant's sub-dataset. This that means that whenever a time-dependent covariate changes its value – for example: if a participant changes from fixed-term to permanent employment – this change of state has to be resembled in the sub-dataset. This aim is being achieved by introducing a split in the sub-dataset at the time-point whenever the state of a time-dependent variable changes (Blossfeld et al. 2007: 137f.). These time-splits, then, contain information on the origin state of the interesting episode, the values of each covariate at the start of the episode, information on starting and ending points of the episode and information whether the episode under consideration is (right-)censored or reaches its end after the event occurred (Blossfeld et al. 2007: 138).

Third, piecewise-constant exponential models in particular require a somewhat more detailed approach to episode splitting. Here, each participant's sub-dataset contains not only all episodes – for example: 10 months of being in education, five months of fixed-term em-

ployment and 35 months of being in permanent employment – but all the reported time-spells. If, for example, a participant reported a total amount of 50 months that he or she spent in his current partnership, his or her sub-dataset will contain 50 rows within the main-dataset. Each row contains information on the participant's time-invariant as well time-dependent covariates.

In this paper we document and describe the data transformation and episode splitting-procedure in the course of our later piecewise constant-exponential models (Blossfeld et al. 2007). First, a short overview over the used variables as well as the sample is given. Then, we document the transformation of our data. All data transformation-procedures as well as statistical analyses were conducted using Stata (Version 14, IC). For details on the empirical background as well theoretical assumptions of our analyses see the overview in Baron (Baron 2015). A general overview over the sample and the study-design is provided by Eickemeier et al. (2016). Due to restrictions in space and time, we could not provide a deeper methodical insight into the basics of event history-analyses. For introductory purposes, we recommend the textbooks by Blossfeld et al. (2007) and Cleves et al. . (2010)

2. Sample description

The empirical analyses within the study rely on a random sample consisting of 1,083 adults. Primarily 13,483 people passed the screening-questionnaire. All remaining participants were determined by complying with certain criteria. We had to make sure that all participants were not only in an age-range of twenty to thirty-five years, but also being in a relationship and working either under a fixed-term contract or under a permanent contract throughout the survey. The interviews for our data collection were conducted in a standardized way from November 2012 until March 2013.

Of the 1,083 adults, 543 indicated that they had worked at least once under a fixed-term contract during their occupational biography, whereas 530 participants reported that they had worked under a permanent contract most of their working life so far, but never under a fixed-term contract. These data could be used to separate the sample into a treatment group and a control group. The treatment group consisted those actors who experienced working under a fixed-term contract at least once during their occupational biography, the control group covered the participants who had worked under a permanent contract most of the time. Overall, 617 participants reported they were female, which makes a total of 57% of all interviewees. Furthermore, selection bias throughout the sampling process caused overrepresentation of highly educated persons: 63.2% got A-levels respectively university of applied sciences entrance qualification.

3. Used variables

Within the study we mainly focused on four partnership events: cohabitation, marriage, transition to parenthood and real estate purchase. The spells measuring time until each of those partnership events occurred during each participant's relationship were set as dependent variables. During the interview each participant was asked, if the aforementioned events

already occurred during their partnership². The answers were dichotomized whereat the codes were used as follows: 1 means ‘event did occur’, 0 means ‘event did not occur’. In addition to that we collected precisely the number of months it took until the event did occur³. Those allegations were not listed in a separate variable, but were calculated in the course of data preparation (see section 4). Regarding transition to parenthood, we only inquired the years when the children were born, and stated all birthdates on July of the respective years, in order to ensure the participants’ privacy.

The employment status was set as independent variable. All participants were asked about their employment status during their occupational biography. The employment status is a time-dependent variable. The interviewees were queried about four employment status: episode of working under a permanent contract (Eb_unbefr), episode of working under a fixed-term contract (Eb_befr), episode of unemployment (Eb_al) and being in educational system (Eb_bild). For all four status, the answer was dichotomized with answers coded as 1, when the status occurred during each participant’s occupational biography and 0 when it did not. The length of each spell was calculated on a monthly basis by cumulating the spells for each status.

The length of the each participants’ relationship was also measured in months (pb_dauer). Herefrom, spells and covariates were calculated for the piecewise constant models during the AGIPEB-project (pb1_2jahr, pb2_2_kind_jahr, etc.). For more detailed explanation see section 4.

As already mentioned during the sample description, gender (v8), age (v7_jahre) and educational status (v192) are important for our analyses. Concerning the age, we composed an additional variable by squaring the age (v7_jahre_quadriert). Furthermore, we calculated a time-variant age-variable based on the length of each participant’s reported occupational biography. Additionally, the variable educational status was dichotomized into high (A-levels and university of applied sciences entrance qualification) and low (middle school and lower secondary school) educational level. The variable subjective precariousness (skala_spw) was based on a likert scale (Baron 2015). It was mean centered for the later analyses during the AGIPEB-project (for technical information see section 4).

4. Data transformation

In this section we present the syntax used for episode-splitting. All data transformation was conducted using Stata IC, Version 14. The do-file and data set can be obtained after containing the corresponding author of this paper. The resulting event history data was used for piecewise constant models conducted in a series of studies based on the AGIPEB-project (Baron 2015, Baron, Rapp 2017a; b).

4.1 Preparing data for episode splitting

For all the data transformation and analyses in our recent papers (Baron 2015, Baron, Rapp 2017a; b, Baron et al. 2015), we used version 26 of the AGIPEB-dataset. After loading the data into Stata's memory processor we deactivated manual page turning of the results by using the set more off-command.

Then, we shortened the names of all the variables that provide information on whether a partnership-event has taken place or not.

In order to facilitate the later reshaping of the data from wide- to long-format we rearranged the names of all the indicators of occupational spells.

In preparation of the final episode splitting (see section 4.6) we conducted a provisional `stset`-command in order to normalize all the different process times of our participants. Therefore, we generated a new variable measuring the general time ("gt") within our data set. Each participant's process time was normalized by subtracting the starting point of his or her occupational biography from the greatest possible process time that of the person with the longest occupational biography within the AGIPEB-dataset (296 months). Afterwards we moved the newly generated `gt`-variable to an appropriate position within our variable list and, then, checked the normalization procedure by using the `tab`-command. Later, we used this provisional variable to check for erroneous biographical data among each participant's partnership biography (see below).

Afterwards, we generated a provisional variable measuring whether a partnership event had occurred. Later in the data transformation procedure, this variable was used to determine,

whether a partnership event, based on our participants' information, had occurred within a certain occupational spell or not (see section 4.2).

Using this provisional event variable we conducted a provisional reshape of our dataset. Each row of the reshaped dataset now contains information on a single month of each participant's occupational biography ("ever(1)").

This provisional reshaping of our dataset from wide- to long-format allows for calculating the correct partnership starting points for each participant. First, we renamed the original variable containing time-constant measures of partnership duration (from "pb_dauer" to "pb_dauer_konstant"). Then, we copied the general process time, which is in fact the amount of months for each participant's duration of his or her occupational biography, into the newly created, now time-variant variable. We subtracted 12 months from the general time because we had originally asked our participants to start their reports of occupational events one year before their current relationship had begun ("gt-12"). Furthermore, we set values for pb_dauer to missing if, due to erroneous reports of starting points of occupational biographies, the data transformation yielded negative values for partnership duration or values equal zero.

To prepare for implementing time-varying data on each participant's process time we filled each row for each participant with his or her personal process time. This calculation was based on the total amount of each individual's process time and his or her length of occupation biography.

Then, we prepared for the time-varying measures of type of employment to be implemented. Based on our theoretical considerations (Baron 2015) differentiated between five types of employment: fixed term employment ("eb_befr"), permanent employment ("eb_unbefr"), unemployed ("eb_al"), in education ("eb_bild") or other types of employment ("eb_sonst"). All the variables were coded with 0 (type of employment="no") on default.

After rearranging our newly generated variables, we changed the value for each of the five variables from 0 to 1 if a change in employment type took place in a given episode. Therefore, we used the forval-command with i indicating each spell for every employment indicator (during the interviews, a maximum of 12 spells per employment indicator was gathered).

After checking for erroneous data transformation using the tab-command the preparatory transformation of the data for episode splitting was finished.

4.2 Time-variant measure for employment status

Due to theoretical considerations further transformation of the data was conducted to find out about each participant's employment status at the beginning of the partnership. Thus, we built four new variables indication whether a participant was a fixed-term employee ("eb_befr_pbeginn"), permanent employee ("eb_unbefr_pbeginn") or in education ("eb_bild") at the start of his or her partnership. Due to low amounts of cases within the subgroups of unemployed participants as well as among other types of employment both these groups were not considered for this data transformation.

From these newly conducted variables we constructed an index measuring each participant's type of employment at the start of his or her partnership using the following codes: 1 = in education, 2 = fixed-term employment and 3 = permanent employment. This newly constructed variable was named "eb_bstat_pbeginn".

4.3 Data transformation for piecewise-constant exponential model

With piecewise-constant exponential models it is possible to calculate flexible transition rates for each modeled time-span (Blossfeld et al. 2007: 116). In our model, partnership-time is the process time for all our participants. We built twelve variables with each of them encompassing twelve months. Only the last of our time-span variables ("pb_jahr10") encompasses more than twelve months due to this being the variable comprising right-censored cases.

Regarding our models, we decided to use two year-intervals for our time-span variables. So we put together each of two consecutive time-span variables to one new time span-variable ("pb2_jahr1", "pb2_jahr2" etc.). By using the move-command we placed each newly constructed variable at an appropriate position in the dataset.

We constructed a control variable "pb_2jahr_pruef" to check whether all time-span variables had been constructed correctly.

In the next step we changed the variable measuring age in years to a variable measuring age in months. This allowed for implementing a time-variant measure of age into our later piecewise-constant model. After sorting our dataset according to the general process-time ("gt") we replaced the yearly by a monthly measure

Furthermore, we constructed a time-variant variable measuring squared age in years.

Finally, we calculated age in years at the beginning of each participant's partnership.

For our later analyses, a dummy variable for participants' level of education was needed. The resulting variable was coded as follows: participants with A-levels were assigned the value 1 and all others the value 0.

Furthermore, we recoded the scale measuring subjective precariousness from the original metrics (1 = subjective precariousness very low to 5 = subjective precariousness very high) into a more common (0 to 4)

4.4 Excursion: Time-Variant Shares of Different Types of Employment

For all types of employment status we calculated shares of months spent in each type among each participant's total amount of time-spells. Using these calculated shares, we built a new time-varying variable for each type of employment status. We did not use this variable in our later model, however it could be useful for future analyses to draw on these variables

when, for example, testing for effects of different types of labor market integration on partnership-stabilizing events (Baron 2015).

First, we built our time-variant variable for measuring cumulated shares of fixed-term employment among each participant's occupational life-course ("eb_befr_rel") with values of 0 for each spell on default.

Dividing each participant's cumulated shares of fixed-term employment by each participant's total amount of reported months spend in occupation yielded our time-variant shares of fixed-term employment ///

among each participant's occupational life-course. Note that we used the variable built in the first step of this excursion ("eb_befr_rel") as the target-variable for the calculation process.

4.5 Final Episode Splitting

To facilitate the final episode-splitting, we had to construct a variable measuring the occurrence (or non-occurrence) of the theoretically interesting partnership-stabilizing event for each spell. As an example, we focus on the variable "pb2_fail" that measures whether participants have transitioned into parenthood (pb2_fail=1) or not (pb2_fail=0). Building on the replace-command, we use each participant's risktime and the event-status to allow for constructing time-variant measures of the event-status. Afterwards we deleted ("drop") all those spells where each participant's general process-time exceeded the time at risk.

Then we constructed time-variant starting- and ending-variables for each spell for each participant. The maximum amount of spells and, thus, the endpoint of each participant's occupational biography is marked by the time-variant variable pb_dauer (which means: duration of partnership, for transformation-instructions see section 4.1). Hence, we generated a variable measuring the final date ("pb_end") that used the data of the original variable "pb_dauer".

We calculated the time-variant starting points for each spell by subtracting one month from each spell's ending-point.

Finally, our episode-splitting command relied on the aforementioned event- and time-variables. For general instructions on reshaping and episode-splitting with Stata see (Cleves et al. 2010: 193-197). We sorted our data along each participant's ID and duration of life-courses.

4.6 Additional data transformation

We used a shortened scale for subjective precariousness that contained only three instead of four of the original items. The shortened scale was constructed as an additive index. For details on the scale-building as well as reliability and validity analyses see (Baron 2015). Furthermore, we used codes ranging from 0 (very low subjective precariousness) to 4 (very strong subjective precariousness), thereby replacing the original codings.

For our piecewise-constant model we needed mean-centred predictors in order to provide intuitive calculations of interaction effects (Aiken, West 1991). As an example we report data transformation for the construct subjective precariousness. This variable measures feelings of uncertainty and economic restrictions associated with fixed-term employment (Baron 2015). First, we calculated the scale-mean for subjective precariousness, excluding all missing values for each predictor used in the later model.

Then, we mean-centred each participant's value for subjective precariousness and later moved the new mean-centred scale to an appropriate position in the dataset.

Last, we cleared the sample from spells for unemployment and other types of employment for each of the three types of employment status under consideration. We decided to do so because of very low incidences of unemployment /// spells and other types of employment spells in our sample.

4.7 Syntax for piecewise-constant exponential model

Before calculating our piecewise-constant model, we ordered Stata to provide us with sample statistics.

We used Kaplan-Meier method to estimate survival curves for each transition. Additionally, we plotted the function by using the `sts` graph-command.

We calculated our model by using the `streg`-command and the option `"dist(exp)"`, expecting a (piecewise) constant hazard rate (Blossfeld et al. 2007: 116ff.). Therefore, we implemented the time-span variables (`"pb_2jahr2"`, `"pb_2jahr3"` etc.) as predictors.

As a final step we calculated separated models for each gender. First, we calculated models for women only ($v8=1$), then for men only ($v8=0$).

5. Conclusion

In this paper we presented data transformation procedures in the course of conducting several piecewise constant-models using event history data based on the AGIPEB-project. Therefore, we conducted several reshaping- as well as recoding-procedures to facilitate episode splitting of our event history data. For our data transformation as well as later empirical analyses we used Stata IC, Version 14. Empirical results using the aforementioned event history data can be obtained from several publications, one of them still being under review at the time of finishing this working paper (Baron 2015, Baron, Rapp 2017a; b).
